HUMBOLDT CAPITAL CORPORATION INCREASES ITS INTEREST IN PARIS ENERGY INC.

Humboldt Capital Corporation (“Humboldt”) (TSX-V: HMB) advises that it has acquired an additional 233,000 common shares of Paris Energy Inc. (“Paris”) (TSX-V: PI) through the facilities of the TSX Venture Exchange. As a result, Humboldt has increased its holdings to 1,645,449 common shares, 17.2% of the outstanding shares. Humboldt together with its major shareholder, Robert W. Lamond, own and control an aggregate of 1,826,979 common shares or 19.1% of the outstanding shares of Paris. Humboldt may be considered to be acting jointly on in concert with Mr. Lamond under applicable securities laws.
